As a residential educational institution, LKSEC is committed to providing a safe, secure, inclusive, and nurturing environment where every child is protected from abuse, neglect, exploitation, bullying, harassment, discrimination, and all forms of violence. The Child Protection Committee serves as the school's apex body for promoting child safeguarding, ensuring compliance with statutory requirements, fostering awareness, monitoring preventive measures, addressing child protection concerns in a timely and confidential manner, and recommending appropriate corrective and preventive actions. The Committee shall function with fairness, sensitivity, confidentiality, and in the best interests of the child, while promoting a culture of vigilance, accountability, and zero tolerance towards any form of child abuse or misconduct.
