- Date of Birth Certificate of Child issued from MCD.
- Proof of Residence Ration Card/voter I-card/Adhaar Card/Passport/ Electricity Bill/ MTNL Bill/ Domicile Certificate of child or of his/her parents.
- Proof of Sibling (if applicable) Latest fee slip.
- Proof of Alumni (if applicable)-School Leaving Certificate/Sr. Sec./Secondary Board Certificate.
- Medical certificate from government hospital (for child with special needs).
- Proof for single parent (Death Certificate/Divorce Papers/Requisite support documents issued by recognized Govt. Office), if applicable.
- Certificate in support of belonging to SC/ST/OBC (if applicable).
- Aadhar Card of child.

(Parents must bring a passport size photograph each of the child, father and mother for admission after verification of documents.)
