- 8. Being aggrieved by the said order school has filed its objection vide letter dated 28-05-2024. On 31-05-2024 Mr. Mukesh Dahyabhai Patel, Chairman of the school appeared before the committee and hearing was conducted.
- 9. During hearing it is submitted by authorized persons that if the fees demanded by the school for the years 2024 25 are approved by the FRC then they have no objection further 9% increase in fees for the year 2025 26 over the fees for the year 2024 25 further 8%



increase in fees for the year 2026 - 27 over the fees for the year 2025 - 26 allows then they have no objection. It is further undertake that school shall not collected term fees extra.

- 10. In our provisional order of fee determination for the year 2024 25 we have allowed 5% increase in fees over the fees determine for the year 2023 24. As per judgment of Honble' High court in special civil application no. 2352/2021 every self-finance schools may charge two months fees in addition to fees determine by the FRC. That menace school is entitled to collect two months fees upon fees provisionally determine by the FRC. If any school charges two term fee extra it amounts to 16% increase in fees if we do not allow any further percentage then also school is entitle to charge 5% increase as awarded in our provisional order plus 16% which amount to 21% increase in fees.
- 11. Considering the above percentage in mind it is just to increase fees as mention during hearing with the condition not to charge extra term fees. And therefore we determine fees as under:
