#### Aims and Objective of PTA:

- 8 To organize activities for the welfare of the children.

Election of the parent members of the Executive Committee by general body of the parents will be held on 08-10-2025 as per details given hereinafter:

- 1 All the parents of the students studying in this school are members of the general body of the parents.
  - c) The Executive Committee will comprise of 16 members, including 8 representatives of the parents (at least one member belonging to Schedule Caste, Schedule Tribe or socially and educationally backward classes of citizen; not less than two members shall be women). Parent members of the Committee will be elected by the General Body of the parents of the School.
- 3 With the objective to provide fair representation to all sections of parents, classes have been clubbed into 6 clusters as under:

# 4 RULES FOR ELECTION OF THE EXECUTIVE COMMITTEE OF PTA

- a) Only those Parents who have cleared all the School dues pertaining to the months of July to September, 2025 of the session 2025-26 including any other outstanding dues, are eligible for nomination for the election to the Executive Committee of PTA.
- b) One parent (father or mother) of a student, will be eligible to cast vote for a representative of a particular class cluster, in which his/her ward is studying.
- c) Father and mother can cast vote in different cluster in case of having more than one ward studying in different cluster conditioned to: -
  - Father or mother contesting election in two different clusters can vote only in the cluster in which he or she is contesting.
  - Father or mother can vote only once.
- d) During voting hours entry to the School compound will be restricted. The voter parents are required to bring with them Parent copy of student Identity card of their ward.
- e) Voter parents will be required to sign the attendance sheet and their signatures will be tallied with the School record.
